## National Emergency Management Agency Cyclone Response Funding 2022/23

### Proposal

- 1 This paper seeks agreement to increase 2022/23 funding for the National Emergency Management Agency (NEMA) by up to \$23.725 million for contributions to Mayoral Relief Funds and other extraordinary costs incurred in responding to extreme weather events in the North Island which cannot be met from baseline.


### Relation to government priorities

- 2 This is aligned to two of the Government's Wellbeing Objectives:
  - 2.1 Just Transition – supporting the transition to a climate-resilient, sustainable and low-emissions economy by creating a capability to effectively respond to climate and other emergency events.
  - 2.2 Physical and Mental Wellbeing – supporting improved health outcomes for all New Zealanders and minimising COVID-19 and protecting our communities through providing an effective cross-government emergency response to potentially concurrent events that will create significant health and wellbeing impacts to many New Zealanders.

### Background

- 3 North Island extreme weather events, including Cyclone Gabrielle, have caused significant damage to the northern and eastern parts of the North Island, including Northland, Auckland, Bay of Plenty, Waikato, Tairāwhiti, Hawke's Bay and Tararua.
- 4 On 16 February 2023, Ministers with Power to Act approved government contributions to disaster (Mayoral) relief funds in Tairāwhiti and Hawke's Bay totalling \$2 million.
- 5 On 20 February 2023 [CAB-23-MIN-0048 refers] Cabinet agreed that Ministers with Power to Act could approve Government contributions to Mayoral Relief Funds that are sought before the next Cabinet meeting, for funding over \$100,000 noting the Minister for Emergency Management's intention to make additional contributions to local authorities' relief funds. Ministers with Power to Act signalled their intention to do so in Northland, Bay

of Plenty and Waikato Regions, Tararua and Masterton Districts and Auckland, with contributions totalling \$1.725 million.

- 6 NEMA applied \$3.725 million of funding from within the Emergency Management Leadership and Support multi-category appropriation (MCA) in Vote Prime Minister and Cabinet to initially meet the Crown contributions to disaster relief funds.
- 7 In responding to the impacts of extreme weather events, NEMA has activated the National Crisis Management Centre and deployed significant resources across affected regions to assist local authorities.
- 8 Cabinet approval is now sought to increase 2022/23 funding for Vote Prime Minister and Cabinet to accommodate extraordinary costs associated with the response to the extreme weather events.

- 10 The funding sought is separate from, and additional to, funding that is under consideration to enable contributions of up to \$30 million to local authorities towards urgent removal from residential properties of solid waste and silt caused by Cyclone Gabrielle.

### Analysis

- 11 The Government was able to rapidly advance \$3.725 million in disaster relief funding to communities affected by Cyclone Gabrielle from the Emergency Management Leadership and Support MCA in Vote Prime Minister and Cabinet as, while full year expenditure is committed, the year-to-date expenditure was sufficiently less than the annual appropriation to allow headroom for the immediate payment of these contributions.
- 12 In making these decisions, the Minister of Finance was supportive of NEMA seeking subsequent Cabinet approval of an increase to appropriation to backfill for the cost of the contributions.
- 13 NEMA is the lead agency responsible for co-ordinating the management of emergencies resulting from various hazards, using the arrangements in the National Civil Defence and Emergency Management (CDEM) Plan Order 2015 and the functions and powers of the Director, the National Controller and the National Recovery Manager under the CDEM Act 2002.
- 14 The functions under section 8 of the CDEM Act include carrying out response and recovery activities. NEMA supports the Director in carrying out those activities and will activate and co-ordinate national-level response and recovery activities as necessary from the National Crisis Management Centre or its recovery office.
- 15 Costs associated with supporting smaller emergency events are generally managed through reprioritisation of spend by NEMA. NEMA does not hold

budget in reserve for the extraordinary response costs associated with significant emergency events such as the current severe weather event, or in previous years the Canterbury and Kaikoura earthquakes where additional funding was sought to accommodate the extraordinary costs being incurred.

16 Extraordinary costs are being incurred by NEMA for the current response and are likely to total up to \$20 million in 2022/23. These costs include, but are not limited to:

16.1 costs of catering, travel, office equipment and supplies, and surge resource for the extended operation of the National Crisis Management Centre;

16.2 costs to support the deployment of NEMA staff and emergency assistance teams, including international teams, including travel, accommodation and the purchase of supplies;

16.3 welfare and response costs which, if paid by regional Civil Defence Emergency Management Groups / Local Authorities, would mostly have been eligible for reimbursement under the existing non-departmental other expenses Local Authority Emergency Expenses PLA in Vote Prime Minister and Cabinet, but which, due to the scale of the event, have been met directly by NEMA, for example supplies being transported to Hawkes Bay and Tairāwhiti on HMNZS Canterbury.

17 Due to uncertainty around the final value of the welfare costs referred to in paragraph 16.3 above this paper does not propose that any of the increase in funding sought in this paper be considered as an offset against expenditure which would otherwise have been incurred under the Local Authority Emergency Expenses PLA in Vote Prime Minister and Cabinet, for Fiscal Management Approach purposes. Nevertheless, to the extent these costs will now be directly met by NEMA, expenses incurred under the PLA will be commensurately lower.

18 The extraordinary costs fall into the 2022/23 financial year. 9(2)(g)(i)

20 I therefore propose further funding of up to \$23.725 million for 2022/23 to enable NEMA's programme of work to continue for the remainder of the 2022/23 financial year.

- 21 As the extent of the response and the ongoing support required from NEMA is not yet clear, it is possible that further funding may be sought in 2023/24 to support any extraordinary costs that continue beyond 2022/23.

### Financial Implications

- 22 This paper is seeking an increase to the Emergency Management Leadership and Support MCA in Vote Prime Minister and Cabinet for 2022/23 for:
- 22.1 \$3.725 million contributions to Mayoral Relief Funds recently announced by the Crown that NEMA is unable to manage from existing funding; and
  - 22.2 increased operating funding of up to \$20 million for NEMA due to the extraordinary level of expenditure incurred in respect of this response which cannot be met from within existing funding.
- 23 Cabinet agreed on 27 February 2023 to apply a total of \$8.5 million from 2022/23 COVID-19 All of Government Response and Health and Disability System Reform underspends in Vote Prime Minister and Cabinet to the cost of establishing and operating the Cyclone Recovery Taskforce and the Cyclone Recovery Unit and to other related cyclone and extreme weather response and recovery expenditure in the Department of the Prime Minister and Cabinet, and specifically to apply \$2.5 million from these underspends to provide initial funding for a new departmental output expense appropriation "Extreme Weather Events All of Government Response" [CAB-23-MIN-0056 refers].
- 24 Currently \$6 million from the underspends noted in paragraph 23 above has not been specifically allocated to cyclone and extreme weather response and recovery expenditure.
- 25 This paper proposes that the \$20 million sought for NEMA extraordinary costs be sourced from the remaining \$6 million noted in paragraph 21 above and from \$14 million new funding.
- 26 Further funding may be sought in 2023/24 to support any extraordinary costs that continue beyond 2022/23.
- 27 The funding sought for 2022/23 as described in paragraph 22.2 above is set out in the table below. The amount has been determined using an estimate of known costs to NEMA for the response (\$10 million) and an allowance (\$10 million) to ensure sufficient capacity for further costs associated with the current response and for any significant emergency events that may occur between now and 30 June 2023. These events may occur after final funding decisions for changes to appropriations for the 2022/23 Supplementary Estimates have been finalised in April 2023.

- 28 The \$10 million allowance in the table above ensures capacity to manage further extraordinary response costs that may emerge, often with short notice, and to meet extraordinary expenditure should another significant event occur before the end of the 2022/23 financial year. It also provides capacity if, as part of the response, Ministers with Power to Act were to agree further Crown contributions to Mayoral Relief Funds or other matters to be supported by NEMA.
- 29 To the extent that funding is approved now there won't be a need to include it in a proposed upcoming omnibus process being led by the Treasury to address agencies' immediate funding pressures in respect of the response.
- 30 This paper does not propose the carry forward of any 2022/23 underspend to 2023/24, and so any unspent funds will be returned to the Crown as part of the Department of the Prime Minister and Cabinet's 2022/23 operating surplus.
- 31 A fiscally neutral adjustment is also required in the Shared Support Services appropriation within Vote Finance. The shared service function of the Treasury provides the corporate functions of Finance, Human Resources and Information Technology to the Department of the Prime Minister and Cabinet and NEMA, and a portion the additional funding sought will be for the provision of corporate functions. This fiscally neutral adjustment is to avoid unappropriated expenditure in Vote Finance in delivering this service.

### Legislative Implications

- 32 There are no legislative implications.

## Impact Analysis

33 There are no identified impacts.

## Population Implications

34 Emergency events have widespread impacts on many population groups. The proposals in the paper acknowledge these impacts and are designed to ensure NEMA is able to maintain its response, recovery, system assurance and stewardship roles to an appropriate level.

## Human Rights

35 There are no human rights implications.

## Consultation

36 The Department of the Prime Minister and Cabinet and The Treasury have been consulted and both are supportive of this proposal.

## Communications

37 Specific communications about this paper are not proposed as it does not contain significant policy decisions. Information about the changes to funding will be published in the 2022/23 Supplementary Estimates of Appropriations for Vote Prime Minister and Cabinet and included in any relevant Budget 2023 communications as necessary.

## Proactive Release

38 I intend to include this paper for release following proactive release of Budget 2023 materials.

## Recommendations

The Minister for Emergency Management recommends that the Committee:

- 1 **note** that on 16 February 2023, Ministers with Power to Act approved government contributions to disaster (Mayoral) relief funds in Tairāwhiti and Hawke's Bay totalling \$2 million;
- 2 **note** that on 20 February 2023 [CAB-23-MIN-0048 refers] Cabinet agreed that Ministers with Power to Act could make additional contributions to local authorities' relief funds in Northland, Bay of Plenty and Waikato Regions, Tararua and Masterton Districts and Auckland, totalling \$1.725 million, and that the necessary agreement from Ministers is currently being sought;
- 3 **note** that the contributions referred to in recommendations 1 and 2 above applied funding from within the Emergency Management Leadership and Support multi-category appropriation (MCA) in Vote Prime Minister and Cabinet, and that while year to date expenditure is less than the annual



appropriation budget, full year expenditure for the appropriation is already fully committed;

4 **note** that when Ministers with Power to Act approved the payments noted in recommendations 1 and 2 above it was also noted that the Minister of Finance supported the National Emergency Management Agency (NEMA) seeking subsequent Cabinet approval of an increase to appropriation for the cost of the mayoral relief fund contributions;

5 **note** that NEMA is incurring extraordinary operational costs estimated at \$20 million in 2022/23 in responding to the 2023 extreme weather events and is unable to meet these costs from within its baseline;

7 **note** that following Cabinet agreement on 27 February 2023 to apply a total of \$8.5 million from 2022/23 COVID-19 All of Government Response and Health and Disability System Reform underspends in Vote Prime Minister and Cabinet to the cost of establishing and operating the Cyclone Recovery Taskforce and the Cyclone Recovery Unit and to other related cyclone and extreme weather response and recovery expenditure in the Department of the Prime Minister and Cabinet, and to specifically apply \$2.5 million from these underspends to provide initial funding for a new departmental output expense appropriation "Extreme Weather Events All of Government Response", there remains \$6 million from the underspends that has not yet been specifically allocated to cyclone and extreme weather response and recovery expenditure;

8 **agree** that the remaining \$6 million referred to in recommendation 7 above be applied to partially meet the estimated \$20 million 2022/23 extraordinary response costs being incurred by NEMA;

9 **note** that following the action agreed in recommendation 8 above the 2022/23 underspend in Vote Prime Minister and Cabinet available for application towards response costs as described in recommendation 7 above will have been fully utilised;

10 **agree** to the following fiscally neutral transfers for 2022/23 only to give effect to the decision in recommendation 8 above:

10.1 transfer \$4.5 million from the Health and Disability System Reform departmental output expense appropriation in Vote Prime Minister and Cabinet to the Emergency Management Leadership and Support MCA in Vote Prime Minister and Cabinet; and

10.2 transfer \$1.5 million from the COVID-19 All of Government Response departmental output expense appropriation in Vote Prime Minister and



Cabinet to the Emergency Management Leadership and Support MCA  
in Vote Prime Minister and Cabinet;

- 11 **agree** to increase funding in Vote Prime Minister and Cabinet by \$17.725 million for 2022/23 only to meet increased costs for Crown contributions to Mayoral Relief Funds and the balance of the estimated \$20 million other extraordinary costs incurred by NEMA in responding to 2023 extreme weather events that cannot otherwise be met from within current baseline;
- 12 **agree** to increase spending to provide for costs associated with the policy decisions in recommendation 10 and 11 above, with the following impacts on the operating balance and net debt:

### National Emergency Management Agency: Cyclone Response Funding 2022-23

On 7 March 2023, the Cabinet Extreme Weather Recovery Committee, exercising its Power to Act in accordance with its terms of reference:

- 1        **noted** that on 16 February 2023, Ministers with Power to Act approved government contributions to disaster (Mayoral) relief funds in Tairāwhiti and Hawke’s Bay totalling \$2 million;
  
- 2        **noted** that:
  - 2.1        on 20 February 2023, Cabinet agreed that Ministers with Power to Act could make additional contributions to local authorities’ relief funds in Northland, Bay of Plenty and Waikato Regions, Tairāwhiti and Masterton Districts, and Auckland, totalling \$1.725 million [CAB-23-MIN-0048];
  - 2.2        the necessary agreement from Ministers is currently being sought;
  
- 3        **noted** that:
  - 3.1        the contributions referred to in paragraphs 1 and 2 above applied funding from within the Emergency Management Leadership and Support multi-category appropriation (MCA) in Vote Prime Minister and Cabinet;
  - 3.2        while year to date expenditure is less than the annual appropriation budget, full year expenditure for the appropriation is already fully committed;
  
- 4        **noted** that when Ministers with Power to Act approved the payments noted in paragraphs 1 and 2 above, it was also noted that the Minister of Finance supported the National Emergency Management Agency (NEMA) seeking subsequent Cabinet approval of an increase to appropriation for the cost of the Mayoral Relief Fund contributions;
  
- 5        **noted** that NEMA is incurring extraordinary operational costs estimated at \$20 million in 2022/23 in responding to the 2023 extreme weather events, and is unable to meet these costs from within its baseline;

10 **agreed** to the following fiscally neutral transfers for 2022/23 only to give effect to the decision in paragraph 8 above:

10.1 transfer \$4.5 million from the Health and Disability System Reform departmental output expense appropriation in Vote Prime Minister and Cabinet to the Emergency Management Leadership and Support MCA in Vote Prime Minister and Cabinet; and

10.2 transfer \$1.5 million from the COVID-19 All of Government Response departmental output expense appropriation in Vote Prime Minister and Cabinet to the Emergency Management Leadership and Support MCA in Vote Prime Minister and Cabinet;

11 **agreed** to increase funding in Vote Prime Minister and Cabinet by \$17.725 million for 2022/23 only to meet increased costs for Crown contributions to Mayoral Relief Funds and the balance of the estimated \$20 million other extraordinary costs incurred by NEMA in responding to 2023 extreme weather events that cannot otherwise be met from within current baseline;
